2. In this privacy policy, unless the context requires a different interpretation:

- b. References to sub-clauses, clauses, schedules or appendices are to sub-clauses, clauses, schedules or appendices of this privacy policy;
- c. A reference to a person includes firms, companies, government entities, trusts and partnerships;
- d. "including" is understood to mean "including without limitation";
- e. Reference to any statutory provision includes and modification or amendment of it;
- f. The headings and sub-heading do not form part of this privacy policy.

### Scope of this privacy policy

1. This privacy policy applies only to the actions of Forshaw Compliance Solutions Ltd and Users with respect to this website. It does not extend to any websites that can be accessed from this website, but not limited to, any links we may provide to social media websites.

## **Data that is given to us by you**

In each case, in accordance with this privacy policy.

10. We may use your data for the above purposes if we seem it necessary to do so for our legitimate interests. If you are not satisfied with this, you have the right to object in certain circumstances (see the section "your rights" below).

## **Who we share Data with**

11. We may share your Data with the following groups of people for the following reasons:
  - a. Our employees, agents and/or professional advisors – to obtain advice from professional advisors;

In each case, in accordance with his privacy policy.

## Keeping Data Secure

12. We will use technical and organisational measures to safeguard your Data, for example:
  - a. Access to your account is controlled by a password and a username that is unique to you.
  - b. We store your Data on secure servers.
13. Technical and organisational measures include measures to deal with any suspected data breach. ## Data Retention

16. Even if we delete your Data, it may persist on backup or archival media for legal, tax or regulatory purposes.

## Your rights

17. You have the following rights in relation to your Data:
  - a. **Right to access** - the right to request (i) copies of the information we hold about you at any time, or (ii) that we modify, update or delete such information. If we provide you with access to information we hold about you, we will not charge you for this, unless your request is “manifestly unfounded or excessive”.   - b. **Right to correct** - the right to have your Data rectified if it is inaccurate or incomplete.
  - c. **Right to erase** - right to request that we delete or remove your Data from our systems.
  - d. **Right to restrict our use of your Data** - the right to “block” us from using your Data or limit the way in which we can use it.
  - e. **Right to data portability** - the right to request that we move, copy or transfer your Data
  - f. **Right to object** - the right to object to our use of your Data including where we use it for our legitimate interests.
